# October 2021: Index Account Updates

At Prudential, we are committed to maintaining financial discipline and continue to review impacts to the index accounts, and the upside they can offer. Effective October 1, 2021, there will be improvements to cap rates for some IUL products. Please note, there are no changes to the spreads from the previous month.

The cap rates for impacted index accounts will be effective for index segments starting October 1, 2021. Please see below for the complete list of Index Account changes.

A letter will be sent to policy owners when there are changes to index accounts, informing them of the new cap or spread and that the future segments will be impacted. The letter also indicates that these changes may result in different values than were shown in their most recent illustration and how they can request a current illustration.
